## **President's Message**

2005 was a busy and challenging year for Industrial Hygiene, both locally and nationally. Georgia became one of the few states to enact a state title protection law. Now more than ever, protection and expansion of the industrial hygiene field are increasingly important as our job responsibilities grow. Despite the urgent need for EHS and IH professionals, decreasing numbers of students are participating in safety and health undergraduate and graduate programs. To counter this trend, OSHA has established a Youth Alliance with the Mobile. Alabama school district and is attempting to expand this initiative to cover the entire state. I believe that our local section should pursue establishment of a similar program, which provides community

outreach to students, educators and parents in Georgia. Please let me know your thoughts regarding this proposal.

Georgia also needs to develop students' skills and knowledge of safety and health topics before they graduate from high school so that they have a better idea of what they should expect in their first jobs. Recently, AIHA developed a Student Activities Working Group (SAWG), with a K-12 focus area, and other states are looking to partner with organizations such as OSHA, local school districts, and ASSE. Professional development continues to be an area of critical importance for IHs. This fall, I had the opportunity to attend the Future Leaders Institute sponsored by AIHA. The Local Section is looking to expand its options for payment of



## **GLS Members Participate In Future Leaders Institute**

Three members of the Georgia Local Section participated in the AIHA's inaugural Future Leaders Institute (FLI) September 29 - October 2, 2005 in Oak Brook, Illinois. Ryan Langton (FLI cochair), Michelle Dunham (FLI advisory committee member), and Margaret Buckalew (FLI attendee) participated in this innovative new program. The FLI was developed by the AIHA to address recent trends in membership demographics and the need to identify younger professionals who will help drive the association as well as the field of industrial hygiene in

the coming years. Funded by a special grant from the AIHA Board and sponsored by SKC, the AIHA invited over 40 younger OEHS professionals from a candidate pool of 110 applicants. The institute was facilitated by Jeffrey Cufaude, of Idea Architects in Indianapolis, Indiana and was geared toward understanding the various styles of leadership. Focus areas included broadening interpersonal and organizational perspectives, collaborative/ teamwork efforts, and managing your future. Feedback from the participants was extremely positive, and many left the

institute with tangible leadership skills that they were able to apply in their respective OEHS careers. President-elect Margaret Buckalew called the program "...the most valuable professional training I have ever received... a truly rewarding learning experience that re-invigorated my passion for the profession and my place in it."

A number of storms affected residents and businesses in our region during the last year, and weather forecasters are predicting similar incidents for 2006. One of the topics emphasized by these natural disasters is the important role that industrial hygienists and other occupational and environmental professionals should play in emergency responses. A new white paper addressing these roles and responsibilities was recently developed by the AIHA Emergency Preparedness and Response Task Force,, a group of experts in the field of industrial hygiene and emergency response. I have had an opportunity to visit the hurricane-affected areas along the Gulf Coast, and mass media depictions of the damage only gives a small picture of the destruction sustained by the region. Through a Susan Harwood grant, GTRI has been conducting free safety and health courses for those working to rebuild the area. The need for assistance and the safety and health hazards will affect the region for years to come, and our local section played a small part by contributing \$200 to the American Red Cross fol-

lowing the hurricane and flooding disaster in the Gulf Coast as part of the AIHA challenge.

The theme for our spring meeting will be Summertime Safety and Health Hazards/Issues, including (but not limited to) heat stress and safety and health issues in the Gulf Coast Region. Next week's meeting on February 22 will focus on metals (both heavy and light) from several viewpoints. Speakers will address the topic on many fronts, including standard and exposure limit rulemaking, exposure assessment, and laboratory analysis. We look forward to seeing you there.
