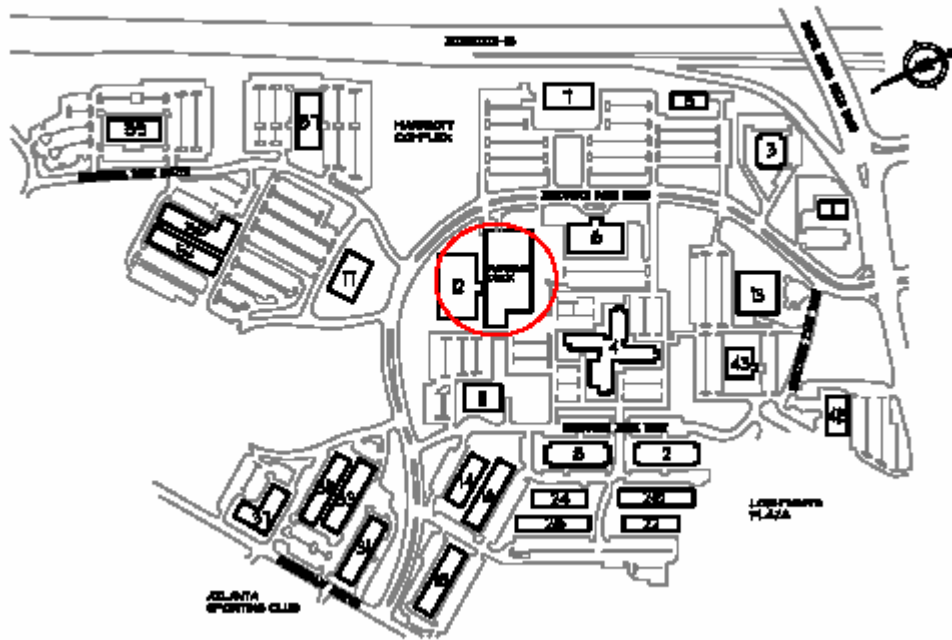

DIRECTIONS:

From downtown:

I-85 North to North Druid Hills Exit (Exit #89). Turn right onto North Druid Hills and take the first right onto Executive Park Drive. Building 12 will be on your left in approximately ¼ mile. Look for sign post for Building 12. You can park in the parking deck or in parking spaces around the building. Enter into the main lobby. A security guard will issue you a visitors pass and direct you to conference room 1002a.

From the North:

Take I-85 South North Druid Hills Exit (Exit #89). Turn left and cross over I-85. Turn right onto Executive Park Drive. Building 12 will be on your left in approximately ¼ mile.
